Letter to IDHDP-IDPC on the EC position on the Russian government's policy on drug dependence treatment and HIV prevention (inputs received also from DG-Justice and EEAS)

- 28 June: video-conference between SANCO, ECDC, DEVCO, delegation on HIV/AIDS situation and EU HIV projects in Russia $\,$
- 2 October: videoconference between UNAIDS (Moscow), WHO (Moscow), UNDP (Moscow), ECDC and DG-SANCO (Cd)/EEAS (Moscow) on the HIV-AIDS situation in the Russian Federation. The main aim of this videoconference was to have an informal exchange of views/discussion/brainstorming on the situation of HIV-AIDS in the Russian Federation and ways, possible options, ideas, policy suggestions on how the current trend of HIV infection rate increases in RF can be reversed, taking into account the broader European/world implications.
- 18 October 2012: participation to the European Commission Russian Federation Subgroup on Communicable Diseases with a presentation on the HIV/AIDS policy was given.

HIV situation in Greece:

Letter in answer to Mrs. Cosmaro and Mrs. Zakowicz, co-chairs of the CSF, addressing the situation in Greece where 12 female sex workers were arrested, forced to HIV testing, and their personal data, photographs and medical records were published (inputs from DG Justice)

- 5 September 2012: audio-conference between ECDC and SANCO C4/C3 on the risk assessment on the HIV situation in Greece. ECDC will carry on a second mission to Greece (17 September 2012)
- 9 October 2012: audio-conference between ECDC and SANCO C4 to receive updates on the second technical mission of ECDC in Greece and on the status of the Risk Assessment
- 17 October 2012: received the draft of the Risk Assessment for comments
- 28 November 2012: received the final version of the Risk Assessment before publication
