## What is 'quality' in HIV prevention?

- Quality: Achieving positive health outcomes in a manner consistent with the best available evidence, knowledge and standards.
- **Quality Assurance (QA)** monitors the quality of services and activities against standards, including review, problem identification and corrective action.
- Quality Improvement (QI) identifies, implements and evaluates strategies to increase the capacity to fulfil and exceed quality standards.

# Why focus on quality in HIV prevention?

- Improve political commitment and funding support
- Ensure quality during scale-up and transfer
- Build evidence-base for sound interventions
- Support projects in demonstrating (cost-)effectiveness.

- Practical tools and capacity to use them
- Network of practitioners and experts
- Quality principles and criteria for wider dissemination

# Quality in HIV Prevention: Joint Action Objectives

- Increase the number of practical QA/QI tools available
- Increase the capacity for using formal QA/QI processes
- Increase the number of projects using QA/QI
- Develop, adopt and disseminate a set of agreed quality principles and criteria for HIV prevention
- Increase the number of national and regional strategic and action plans that incorporate formal QA/QI activities.
