Background and quick facts

- In a 2004 inventory 100 NGOs indicated to need a tool that would facilitate access to European good practices
- The realization of the Clearinghouse was part of the project “European Partners in Action on AIDS (2006-2008) funded within EU Public Health Programme 03-08
- The Clearinghouse was built onto www.aidsactioneurope.org and launched in March 2007
- The Clearinghouse seeks to meet the need of the wider European Region and is therefore available in English and Russian
- Continuation through operating grant new EU Public Health Programme



Universal access & health inequalities



The Clearinghouse aims to contribute to tackling health inequalities between Western and Eastern Europe and work towards universal access for key populations to prevention, treatment, care and support.

User satisfaction and future plans

- At the end of 2008 the Clearinghouse had 490 user accounts, 554 uploaded good practices which were downloaded more than 27000 times
- A large-scale usability test was carried out in 2008 and generated responses about the content, accessibility and design
- A pop-up survey measured positive opinions from more than 100 users on relevance, clarity, completeness and usability of the information
- Recommendations from the evaluation will be implemented in April.
