Draft Law #8711 - Human Rights Violation

Draft law #8711 "On introduction of Changes to Certain Legislative Acts of Ukraine (regarding

October 2, 2012 - Parliament approved in the first reading.

Introduces criminal liability for mentioning homosexuality in public sphere with a penalty of up to five years imprisonment.

Amendments to:
Criminal Code of Ukraine
Law "On the print media (Press) in Ukraine"
Law "On Television and Radio"

Law "On protection of public morality"

Draft Law violates principle of non-discrimination.

Human rights at risk:

 Right to peaceful assembly and association
 Right to self-determination

Draft Law #8711 - THREATS

- □ Censorship of mass media
- □ Legalization of social exclusion of lesbians and gays, leaving the group alienated
- Ban and criminalization of:
 - Conveying of any type of information related to LGBT
 - > Publishing and distribution of materials on HIV prevention among MSM, while curbing access of MSM to health services
 - > Public actions on LGBT rights
 - Film production, distribution and screening homosexuality and homosexual people
 - > Art projects on the topic
 - Researches on sexuality
 - Exclusion of homo- and bisexuality from sexual education
