


## Strategy



### What 's up About PrEP in France



- 3024 respondents
- Internet and paper survey
- 33.6% aware of PrEP before answering the questionnaire
- Intention to use PrEP is available : migrants, heterosexual men, most-at-risk populations, informal PrEP users
- 4.5 % informal use of PrEP (75% MSM, 12.6% heterosexual men and 9.4% women)
- Much more to come....

- The experience and the needs of people who use " informal " PrEP outside research in France
- On the experiences and expectations of those who use " informal " PrEP in order to design a framework of analysis and assessment of the delivering of PrEP

# ANSM launched a Independent group working on RTU in France

 ANSM decides to create an independent group to analyze the possibility to open RTU (Recommandations Temporaires d'Utilisation) of Truvada for PrEP (exclusivity clause for the experts)

#### 2 commissions

- Risk and benefits of PrEP (toxicity, behavioral issues,...)
- Deliverance framework (medical advice, reimbursement by the healthcare system,....)=>Very important to evaluate also the <u>counseling framework</u>

 The group gave an audition to AIDES and the other members of the civil society

### Minister of Health June 2015

- She asked to ANRS and CNS to produce a report on PrEP to define the role of this tool in the global strategy of prevention
  - Results by the end of the year =>2016 l'année du changement

### What's up PrEP in Europe

Fear no more! Catalysing the empowerment of gay men for HIV prevention, treatment and stigma reduction in Europe

> Activist consultation organised jointly by the European AIDS Treatment Group and UNAIDS Brussels, 22-24 June 2015

### Aim and objectives

- Bringing PrEP on the agenda of the global HIV response,
- Defining the scope of WHO recommendations on PrEP
- Informing the development of WHO guidelines in this area.
- Building on "The HIV Prevention Manifesto: we need PrEP now!" launched by EATG and AIDES in February 2015
- Strengthen further community mobilization for accelerated implementation of more effective and at scale programmes for HIV in the European Union/European Economic Area (EU/EEA).

### Format and participants

- 2 day workshop with emphasis on interaction-debate and work in smaller groups.
- The criteria for selection of participants are:
  - Good knowledge of the latest scientific findings related to PrEP and TasP
  - Understanding the potentials and opportunities of PrEP and TasP for HIV prevention,
     treatment and stigma reduction among gay men and other men who have sex with men
  - Good insight and sensitivity to current life styles, social and political dynamics and networking among gay men and other men who have sex with men in the region
  - Commitment and ability to organize follow up of the recommendations of the meeting
  - Diversity in age, HIV status, geographic location and institutional affiliation
  - Diversity in competences and skills: training, peer education, community mobilization, communication, social media, legal and justice background, advocacy, programming



- A set of recommendations to leading HIV and LGBTI organisations and networks in the EU/EEA region on strategies and actions to increase community awareness, demand and literacy related to PrEP and TasP and reduce stigma related to HIV and use of innovative prevention such as PrEP and PEP.
- Elements of a roadmap to strengthen community political mobilization and activism at local and regional level, including priority targets and actions at country and regional levels, lead organizations, allies and champions.
- Elements of a framework for community action at country and regional to ensure equitable access to new prevention tools and gay friendly testing and treatment services across the EU/EEA region

## **Next Steps**

#### Advocacy national strategy:

- Open-label PrEP in France
- Ask to medical associations to establish guidelines/recommendations concerning informal PrEP use
- Brig value to the coach/support provided by peers
- Advocacy European strategy:
  - ECDC => guidelines
  - EATG
  - European Medicine Agency
  - Gilead (Marketing authorization for prevention use of Truvada...) but also other pharmas developing new PrEP drugs (Jensen, VIIV)
- Develop a **Flash PrEP EUROPE**
- Develop a European PrEP action Plan? => take profit of other successful experience (Slovenia, France, UK,USA,....)
