### Aljona Kurbatova, head of the Infectious Diseases and Drug Abuse Prevention Center at the National Institute for Health Development

She is a sociologist by education and started working in the public health field in 1998. She has participated in elaboration of different public health strategies and serves on the National HIV Prevention Committee and Governmental Committee on Prevention of Drug Abuse. In her current position she is responsible for development, coordination and financing of health and social services in the field of drug addiction, HIV and tuberculosis prevention, as well as implementation of national and international cooperation projects.

In the research field, she is responsible for data of drug-related infectious diseases and drug treatment demand. ### Geoff McCombe, University College Dublin School of Medicine

He is a research fellow at University College Dublin School of Medicine. His research interests lie at the boundary of social psychology and primary care research. To date his research has looked at how inter-group processes influence the lived experience of socially marginalized groups and understanding how group-based processes and psychosocial interventions influence health outcomes. Since July 2016 he has been working on a large scale European Horizon 2020 funded project (Hepcare Europe) focusing on providing an integrated care model for hepatitis C virus treatment involving partnership between primary and secondary care. Areas of interest include: Primary care research, substance use, the prevention and treatment of blood borne virus infections, social psychology, social identity, social inequality.



### Jamie Wilkinson, MPH, MSc, MPharm, Dip HE, FRSPH, MRPharmS, PFPH

Mr Wilkinson commenced his role as Pharmaceuticals and Professional Affairs Adviser of the PGEU in January 2014 before becoming Director of Professional Affairs in April 2015. The Pharmaceutical Group of the European Union (PGEU) is the European Association representing community pharmacists in 32 European countries.

A pharmacist by training, he has practice experience in the community pharmacy sector and academia in the UK, in addition to experience in health policy, professional affairs and advocacy. He was educated at the Universities of Kingston & St Georges London with an MPharm, Master of Pharmacy, an MSc in Social Research Methods from the University of Sussex and an MPH, Master of Public Health from the University of Sheffield. He is a Member of the Royal Pharmaceutical Society UK, a Fellow of the Royal Society for Public Health UK and a Practitioner Member of the Faculty of Public Health UK.



# Lars Peters, CHIP, Department of Infectious Diseases, Rigshospitalet, Copenhagen, Denmark

He is a researcher at the Centre of Excellence for Health, Immunity and Infections (CHIP) in Copenhagen, where he is responsible for research activities in chronic hepatitis B and C including patients co-infected with HIV. He is co-chair of the hepatitis group of the EuroSIDA cohort study, and co-author of the European AIDS Clinical Society (EACS) guidelines for management of HIV/viral hepatitis co-infection and the WHO European Region guidelines for management of HIV/HBV co-infection.

She has 14 years of extensive experience in prison system.
