1. Time limit

The deadline for tender submission is **03/08/2022.** The tender must be received by Deutsche Aidshilfe by e-mail before the end of the time limit for tender submission. The performance will not be subdivided into lots. Alternative tenders are not permissible.

AIDS Action Europe is currently looking for a legal expert consultant to conduct specific tasks within the project Community Led and Based HIV Services - Key to Ending the HIV Epidemic in Europe and Central Asia "Zeroing In - Ending the HIV Epidemic" — on legal and policy barriers of Community Based Voluntarily Counselling and Testing and uptake of Self-testing.

Background





Established in 2004, **AIDS Action Europe** has grown to be one of the largest HIV-related networks in the region. Our network reaches beyond the borders of the European Union and covers all 53 countries in Europe and Central Asia. Our mission is to bring together civil society to work towards a more effective response to the HIV epidemic in Europe and Central Asia.

Members of our network comprise a diversity of 400 NGOs, national networks, AIDS service organisations, activists and community based groups of people living with HIV.

Since 2018 AIDS Action Europe together with CEEISCAT (Centre for Epidemiological Studies of Sexually Transmitted Disease and AIDS in Catalonia) provides Secretariat work for the COBATEST Network. The COBATEST network is a network of community-based voluntary counselling and testing (CBVCT) services created since 2014 in the context of the HIV-COBATEST project, hosted by CEEISCAT.

The COBATEST Network is currently conducting a project Community Led and Based HIV Services - Key to Ending the HIV Epidemic in Europe and Central Asia "Zeroing In - Ending the HIV Epidemic".

The consultancy

The consultancy will consist of the following tasks:

- The consultant will be responsible for undertaking desk research on relevant international guidelines, policies and strategies on community based counselling and testing and self-testing, and for producing a needs assessment report on legal and policy barriers to community based testing and self-testing, based on the rapid assessment of legal and policy barriers to the provision of community based and –led testing services, uptake of HIV self-testing and experience of organisation with HIV self-testing
- Based on the findings of the report, the consultant will be responsible for writing two
 policy papers and policy recommendations: one on legal and policy barriers to community
 based testing and second on legal and policy barriers to self-testing in the WHO European
 Region.

The application comes complete with a price quote, a CV and motivation letter proving that the consultant has competencies and demonstrated experience in:

- conducting research in legal issues and policies
- legal expertise, ideally with a degree in law with a preference to international law
- excellent knowledge of community based voluntarily counselling and testing and selftesting issues in Europe and on relevant international guidelines, policies and strategies
- producing reports





- excellent writing skills
- proficient English language skills.

4. Award criteria
