
Spain

- HIV-related S&D is set as a priority for the Spanish EU Presidency in 2023.
- In the process of joining the partnership.

Expected role of these countries within the GP

- Acting as a champion of the GP within the EU
- Serving as a role model and advocating for more EU countries to support and/or join.
- Advocating for advancing the decriminalisation agenda to ensure enabling legal environment, including through the GP.
- Advocating with other donors the need for additional resources to strengthen the partnership, focus on decriminalisation & a gender transformative approach.

Commitment to date: 33 countries



Impact on Ground: Reaching 10-10-10 Targets



Less than 10% of PLHIV and KPs experience HIV-related Stigma & Discrimination

- National & Regional Synergies: knowledge-sharing/collaboration to streamline & accelerate implementation and ensure greater accountability.
 - Synergies with FCC to accelerate S&D action in 5 GP countries and CDC to advance implementation of prioritized interventions in 3.
 - * CCMs leveraged for GP implementation in PNG, Thailand, South Africa, Uganda, etc.
 - ❖ South-South (Africa-Asia): Shared experiences/knowledge streamlined processes & helped develop/integrate S&D reduction interventions into national HIV programmes. WCA Models of national action plans in 6 WCA countries.
- Strategic Guidance: through catalytic technical support, GP and GNP+ regional & country coordinators ensure S&D reduction strategies embedded into leadership, action plans & interventions.
 - * CAR: Zero Discrimination multistakeholder platform relaunched to oversee/support implementation of joint activities.
 - ❖ Jamaica: jointly developed 5Y plan under BDB aligned w/ 6 settings, GP guidance, NSP & baseline assessment to ensure complementarity. Thailand: costed, multisectoral 5Y plan leveraging political commitment, CSO leadership & partner efforts despite limited resources.
- Actors & Communities Advocates Capacitated: to generate and/or use evidence to implement interventions that reduce S&D barriers.
 - v Iran: emergency workers trained to ensure provision of S&D free HIV services in emergency settings.
 - v Nepal & Laos: training modules on reducing S&D developed by & for PLHIV & KP communities ensured interventions respond to needs.
- **■** Mechanisms Addressing Human Rights Violations in Place
 - ❖ Jamaica: M&E online platform tracking S&D reduction progress, HR Scorecard to improve complementarity & accountability of interventions.
 - * Kazakhstan: data collection website on real-time HR violations of PLHIV & KPs strengthening programme design & access to justice.
 - Iran: anti-discrimination by law for healthcare settings.
 - ❖ Thailand: National code of conduct on HIV prevention and management in the workplace.

Impact on Ground: Reaching 10-10-10 Targets



Less than 10% of women and girls, PLHIV and KPs experience gender inequality & violence

Through Co-leads' & TWG partners' expertise & strategic collaborations, GP is working to bring in a more gendered lens to interventions to ensure rights/needs of women & girls living with HIV in all their diversity are directly addressed in all settings.

Advocacy:

Senegal PLHIV Network held anti-stigma dialogues & developed advocacy strategy for women lawyers' associations & women's rights orgs to reduce S&D against women/girls living with & affected by HIV.

National & Regional Synergies:

- v W4GF: women's rights groups in Uganda & Jamaica supported to enhance south-south collaboration on best practices for incorporated gendered aspects of S&D into interventions.
- v Uganda: OHCHR collaboration led to development of training manuals for healthcare providers on HR-based approaches to SRHR services.

Actors Capacitated: to generate &/or use evidence to implement interventions reducing gender inequalities.

Uganda: community-led scorecard piloted by ICW-EA to support local leaders in implementing interventions for eliminating HIV-related S&D against women & girls

Impact on Ground: Reaching 10-10-10 Targets



Less than 10% of countries have punitive laws & policies

Advocacy & Legal Support:

- ❖ WCA: HIV law reforms underway in Benin, Burundi and CAR with support of HIV Justice Network.
- Kazakhstan: ties established between PLHIV community & parliament to facilitate community-led advocacy around repeal of discriminating laws & communities capacitated to draft shadow reports/advocacy papers.
- Ukraine: review of HIV Law with aim to decriminalize HIV transmission.

Capacitated Actors:

- * Kazakhstan: PLHIV & community trained to navigate intl & local HR instruments & improve efficiency of engagement with lawmakers.
- Ghana: LGBTQI coalition supported in drafting memorandum to Parliament highlighting damaging impact of proposed anti LGBTQ+ Bill.

Improved Legal & Policy Environments:

- v Angola: legal & policy review informed proposed new legal provision allowing <14 yr olds to consent independently to HIV testing.
- v Iran: anti-discrimination bylaw for healthcare settings.
- v Kazakhstan: new Code on People's Health & System of Health Care prohibiting HIV-related discrimination in workplaces.
- CAR: HIV law revised to decriminalize HIV transmission, protect PLHIV and KP's human rights.
- Argentina: with the support of the GP, the new National Bill on HIV, Viral Hepatitis, TB and STIs was approved and promulgated with a strong HR and gender approach.
- Thailand: Code of conduct in the workplace.
