Eligibility Criteria

- The CSF members are organisations with a focus on HIV, TB and viral hepatitis across the European regions.
- Organisations applying for a position in the Coordination Team have to answer the following four questions:
 - Is your organization able to 'represent 'the views/perspectives/issues of the TB community and that across the European region? [Y/N]
 - Is your organisation able to 'represent 'the views/perspectives/issues of the HEPATITIS community across the European region? [Y/N]
 - Is your organisation able to 'represent 'the views/perspectives/issues of the HIV/AIDS community across the European region? [Y/N]
 - Is your organisation able to offer a capacity of 16 days/year to be spent on the Coordination Team? [Y/N]

Coordination Team Member Profile

- Available 16 days/year on lump sum basis
- Join the CSF coordination team calls
- Join communication with relevant stakeholders
- Attend the Civil Society Forum meetings and facilitate parts of the meetings
- Support the preparation of CSF meetings including agenda development,
 outreach to speakers, liaising with members taking part and/or presenting
- Facilitate input of CSF into relevant consultation/policy development processes and relevant medical and policy related events
- Implement agreed advocacy initiatives, e.g. letters, statements, outreach
- Coordinate joint initiatives on behalf of the CSF
- Disseminate information relevant to CSF membership
- Inform external stakeholders about and/or on behalf of the CSF?



Voting Procedure

- Every member organisation has one vote.
- The votes will be casted online
- The first HIV, TB and viral hepatitis organisations in the ranking will be chosen as the Coordination Team. Next two organisations with the most votes will complete the Coordination Team.



Road Map

- 1. Call for interest the member organisation to be a member in the coordination team. Sent out to CSF member organisations by **18.09.2020**
- 2. Applications, showing on 1 page interest and capacity to work in the coordination team, submitted by **30.09.2020**
- 3. Applications sent to the CSF Members by **02.10.2020**
- 4. CSF Members vote by 09.10.2020 electronically via internet the organisations for the Coordination Team
- 5. If a second round is needed, CSF Members vote again by 16.10.2020
- 6. Applying organisations and CSF Members are informed by **21.10.2020** about the results of the voting.
- 7. CSF coordination team starts working in its new composition on **01.11.2020**
